SECTION 5 - FIREFIGHTING MEASURES

Precautions in connection with Fire

Fire fighters should wear full protective clothing and self-contained breathing apparatus (SCBA) operated in positive pressure mode. In case of fire the product may be violently or explosively reactive. Use water spray to disperse vapours. This product should be prevented from entering drains and watercourses.

SECTION 6 - ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Extinguish or remove all sources of ignition and stop leak if safe to do so. Increase ventilation. Evacuate all unprotected personnel. If possible contain the spill. Place inert absorbent, non-combustible material onto spillage. Use clean non-sparking tools to collect the material and place into suitable labelled containers for subsequent recycling or disposal. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

SECTION 7 - HANDLING AND STORAGE

Precautions for Safe Handling

Industrial application: Avoid contact with skin and eyes. Wear overalls, impervious gloves and safety glasses. Use in designated areas with local exhaust ventilation, away from sparks, flames and other ignition sources. Use approved flammable liquid storage containers in the work area. Prevent release of vapours and mists into workplace air. Keep containers tightly closed. Take precautionary measures against static discharges. Do not empty into drains. Ensure a high level of personal hygiene is maintained when using this product, that is, always wash hands before eating, drinking, smoking or using the toilet facilities.

Conditions for safe storage, including any incompatibilities

Industrial application: Store in a cool, dry, well-ventilated area away from sources of ignition, oxidising agents, strong acids, foodstuffs, and clothing. Keep containers closed when not in use, securely sealed and protected against physical damage. Inspect regularly for deficiencies such as damage or leaks. Have appropriate fire extinguishers available in and near the storage area. Take precautions against static electricity discharges. Use proper grounding procedures. Ensure that storage conditions comply with applicable local and national regulations. For information on the design of the storeroom, reference should be made to Australian Standard AS1940 - The storage and handling of flammable and combustible liquids.
